

Q1 Do you have national regulations in your country covering the approval and operation of microvehicles that are not covered by EU-regulation 168/2013?





Q2 If no to 1 above, from your point of view, is a national regulation on microvehicles necessary?









Q5 If yes, to 3 above, which test methods would be utilised within a Technical Service approval process? (tick all that apply)






Q7 If a driving licence is not a prerequisite, is some form of mandatory training required for driving with an e-scooter?
